The Project includes the following Work: Installation of solar photovoltaic generation systems at various locations and points of interconnection around the wastewater treatment plant site. The combined rating of the systems included in the Base Bid is approximately 1.653 MW AC (2.054 MW DC). Bid Alternatives are included for an additional combined rating of approximately 915 kW AC (1,140 kW DC).

Bidders who submit a Bid must be a Plan Holder of record at the Issuing Office. Bids from Bidders who are not on the Plan Holders List may be returned as not being responsive.

The Bid must be accompanied by Bid security made payable to OWNER in an amount of 10% of the Bidder's maximum Bid price.

Bidders shall comply with federal Inflation Reduction Act of 2022 Investment Tax Credit wage rates (Davis Bacon), apprenticeship, and domestic content requirements.

Bidders will be required to comply with all laws, including those relating to the employment of labor and the payment of the general prevailing rate of hourly wages in the locality in which the work is to be performed for each craft or type of worker or mechanic needed to execute the contract or perform such work, also the general prevailing rate for legal holiday and overtime work (including, but not necessarily

limited to 820 ILCS 130/1-12 the "Prevailing Wage Act") as ascertained by OWNER or by the Illinois Department of Labor for DuPage County, Illinois shall be paid for each craft or type of worker needed to execute the contract or to perform such work.

If at the time this Contract is executed, or if during the term of this Contract, there is excessive unemployment in Illinois as defined in the Employment of Illinois Workers on Public Works Act, 30 ILCS 570, as two consecutive months of unemployment exceeding 5%, CONTRACTOR agrees to employ a work force that consists of at least 90% Illinois laborers. An "Illinois laborer" is defined as any person who has resided in Illinois for at least 30 days and intends to become or remain an Illinois resident. The Bidder shall require all subcontractors (if any) to conform with said laws, and any rules or regulations now and thereafter issued pursuant to said laws by Bidder, his subcontractors, and/or anyone working through or on behalf of Bidder or Bidder's subcontractors.

The Wheaton Sanitary District reserves the right to reject any or all Bids, to waive any technicality, and to accept any Bid which it deems advantageous. All Bids shall remain subject to acceptance for <u>85</u> days after the time set for receiving Bids.

Contract award shall be made based on the lowest responsive and responsible Bidder.

A pre-bid conference will be held at 10 A.M. local time, on September 10, 2024, at 1 S 649 Schaffner Road, Wheaton, IL 60189. Bidders are encouraged to attend and participate in the conference.
