

**ORDINANCE NO. 708**  
**WHEATON SANITARY DISTRICT**  
**ORDINANCE ESTABLISHING USER RATES**  
**Rates Effective May 1, 2025**  
**This Ordinance No. 708 Supersedes Ordinance No. 703**

WHEREAS, the Board of Trustees (Board) of the Wheaton Sanitary District (the District) establishes from time to time the rates to be charged to those using the District's systems for collecting, conveying, treating and disposing of wastewater (User Rates); and

WHEREAS, the Board determines it is reasonable to charge private well users a flat rate monthly user charge as stated in this Ordinance; and

WHEREAS, the Board wishes to establish User Rates effective May 1, 2025.

NOW, THEREFORE, IT IS ORDAINED by the Board that User Rates effective May 1, 2025 shall be as follows:

**I. RATES**

**A. Treatment and Conveyance Rate**

Metered Rate	\$5.46 per 1,000 gallons (\$4.08436 per 100 cubic feet) of metered usage
Residential Flat Rate (Based on 4,500 gallons use per month)	\$24.57 per month

**B. Base Charge** – A monthly base charge of \$13.00 per month shall be billed to all customers.

**C. Collector Sewer Maintenance Charge** – A maintenance charge shall be added to each customer billing to help defray the cost of maintaining the sanitary sewer collector system as follows:

Metered Rate	\$0.57 per 1,000 gallons (\$0.42639 per 100 cubic feet) of metered usage
Residential Flat Rate (Based on 4,500 gallons use per month)	\$2.57 per month

**D. Residential Flat Rate Charges** – The total flat rate charge is \$40.14 per month and is based on 4,500 gallons per month. This total flat rate charge of \$40.14 per month may be reduced for residential single occupants (only one person living in the residence) to \$26.57 per month based on 2,250 gallons per month. To be considered for a Reduced Flat Rate, a residential single occupant must meet the criteria in order to submit to the District a completed Residential Certification of Single Occupancy.

**E. Non-Residential Non-Metered Charges** – Consumption is determined by the permitted or calculated population equivalent (PE). The charge is determined by the consumption times

the sum of the Treatment and Conveyance Rate and Collector Sewer Maintenance Charge plus the Base Charge.
